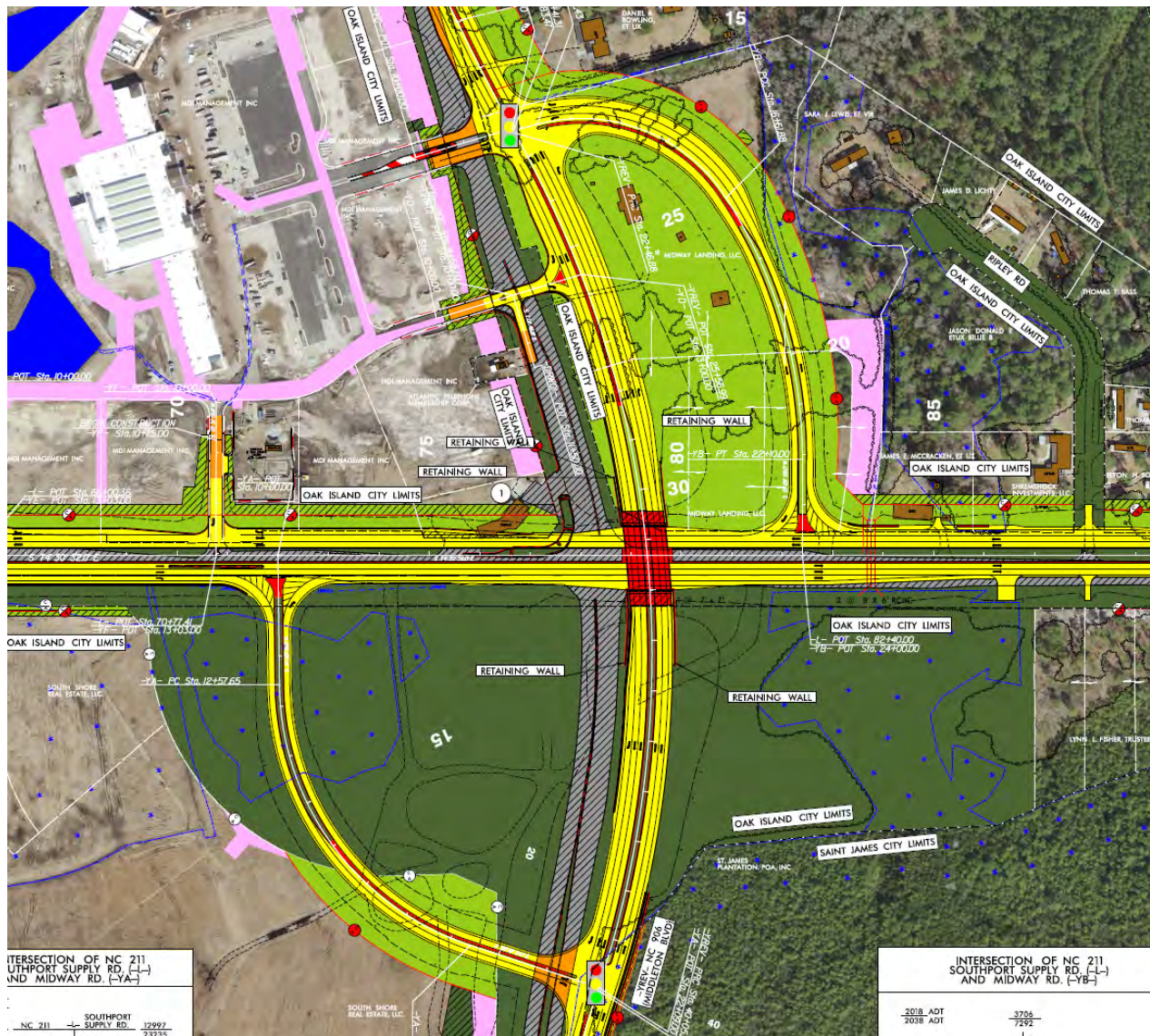

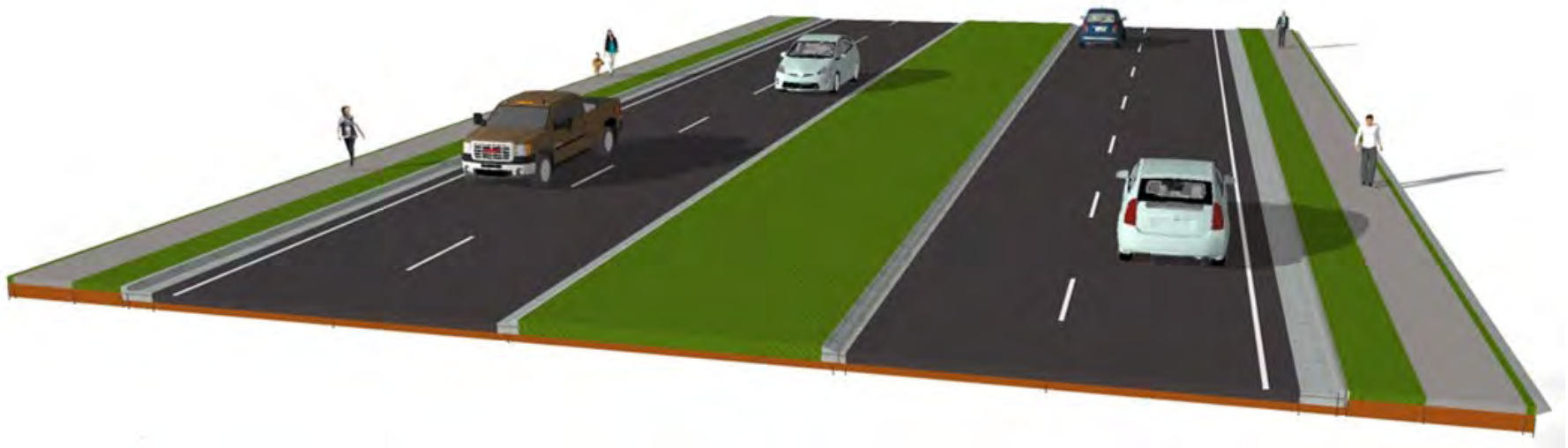
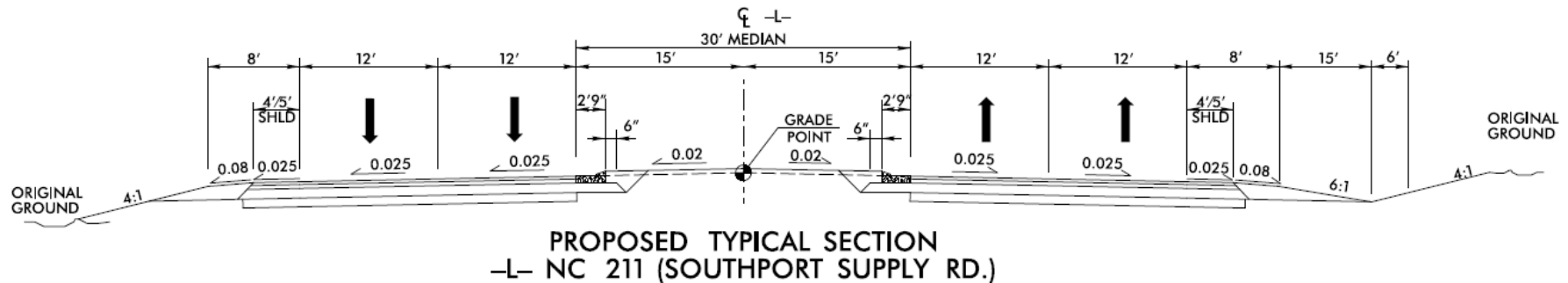

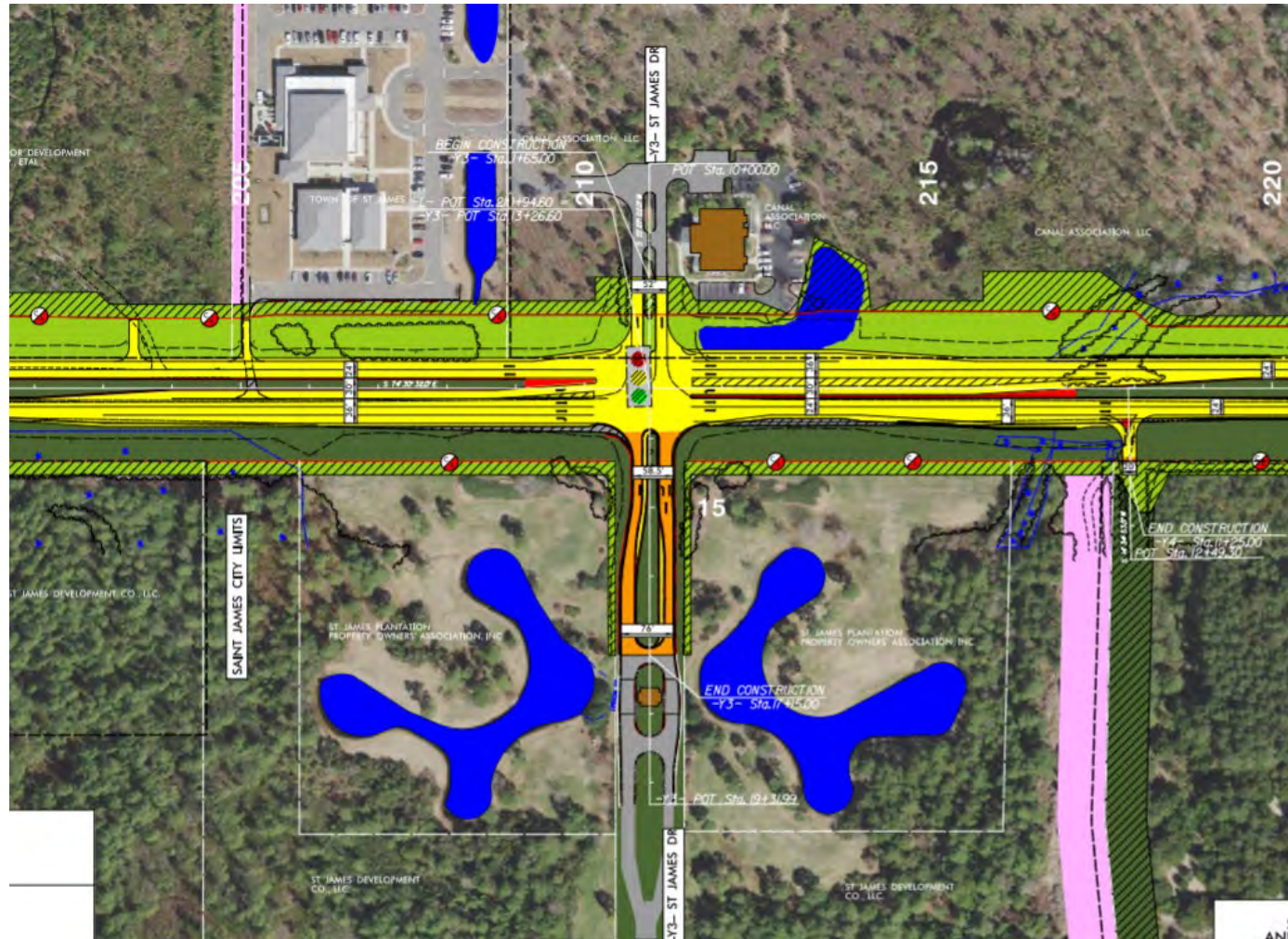
R-5021 - Typical Sections

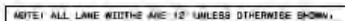
Near Southport - Walmart to NC 87

Entrance to St. James







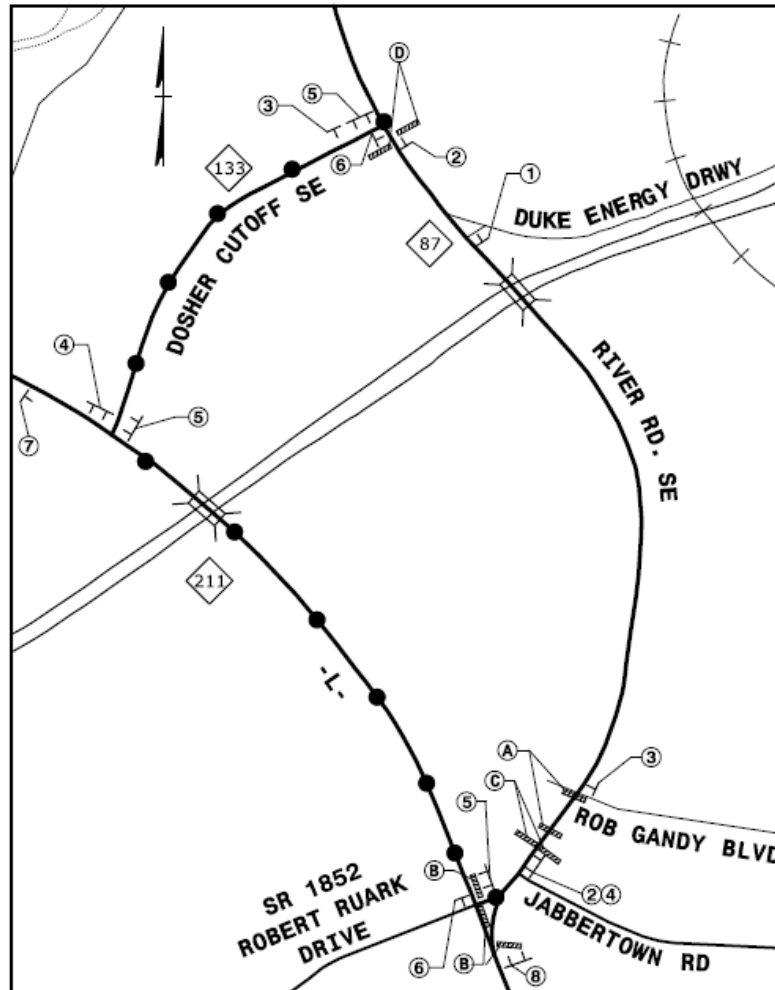

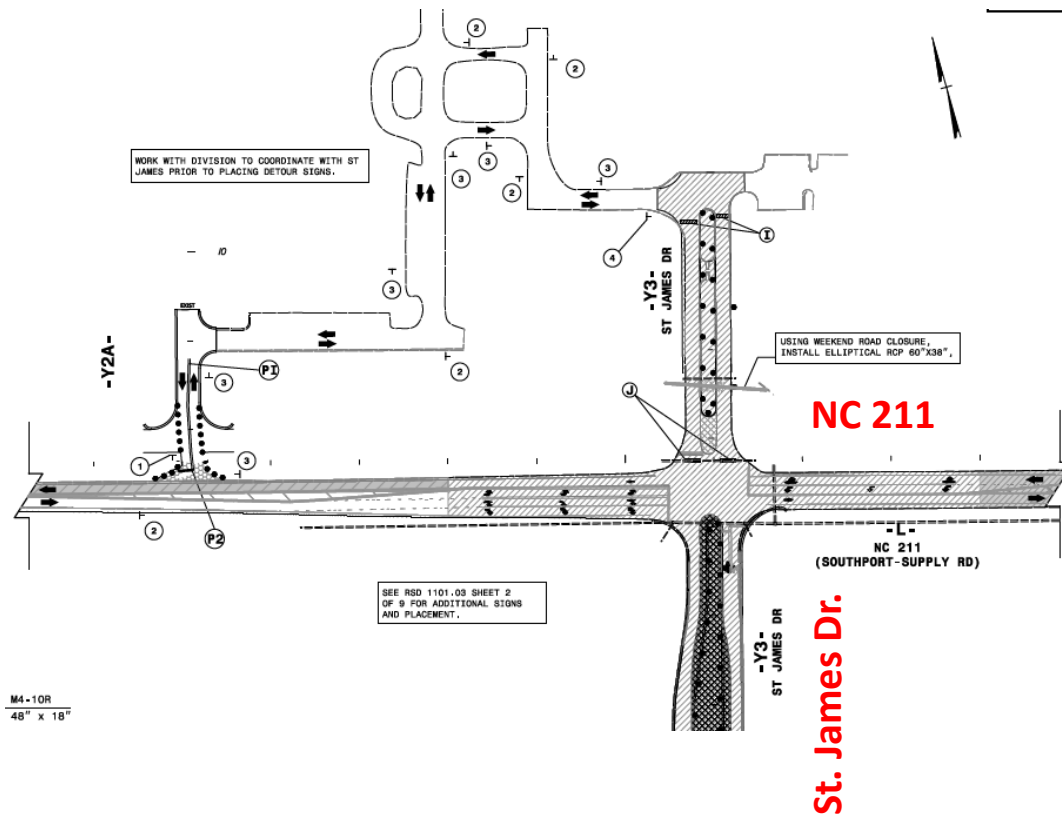

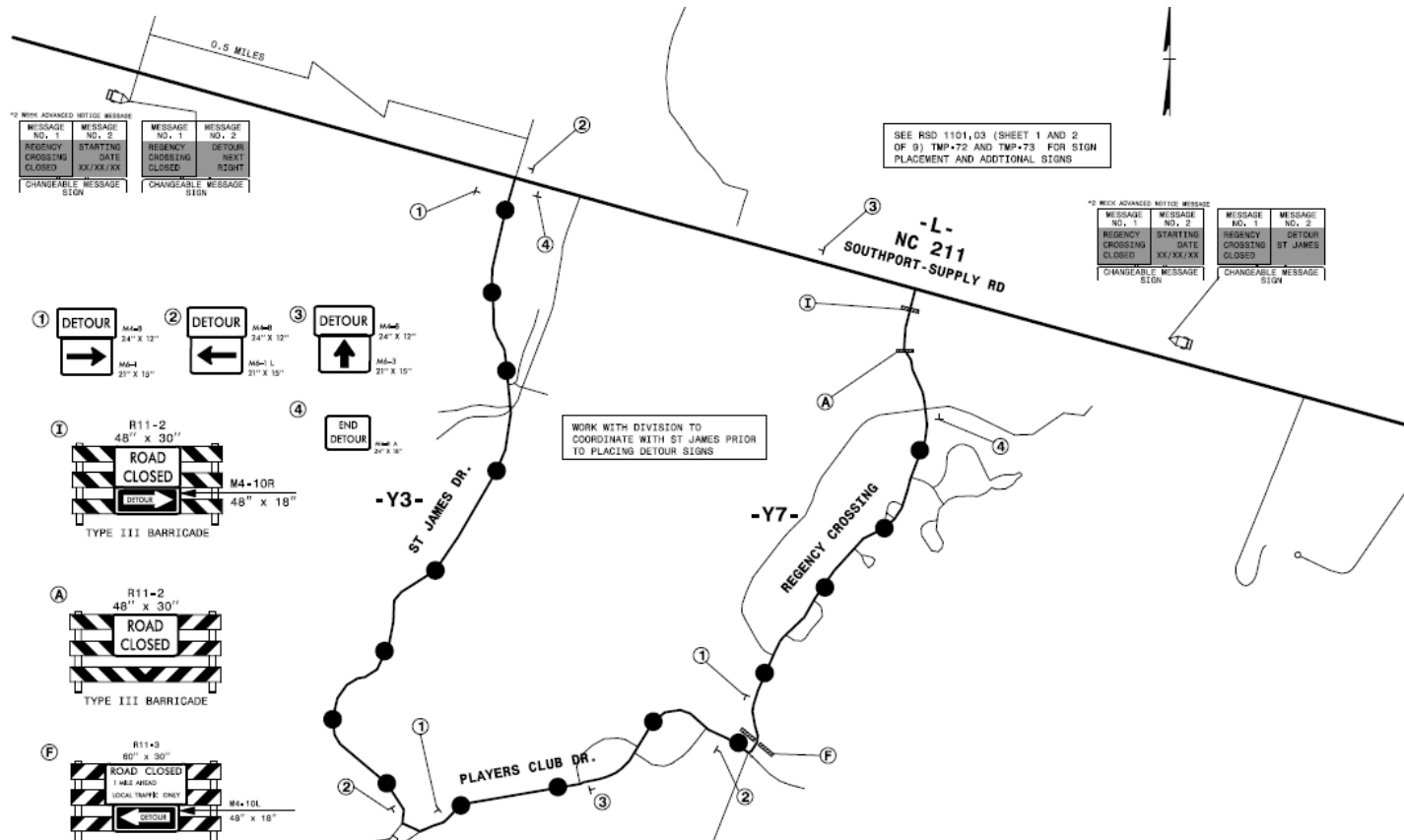

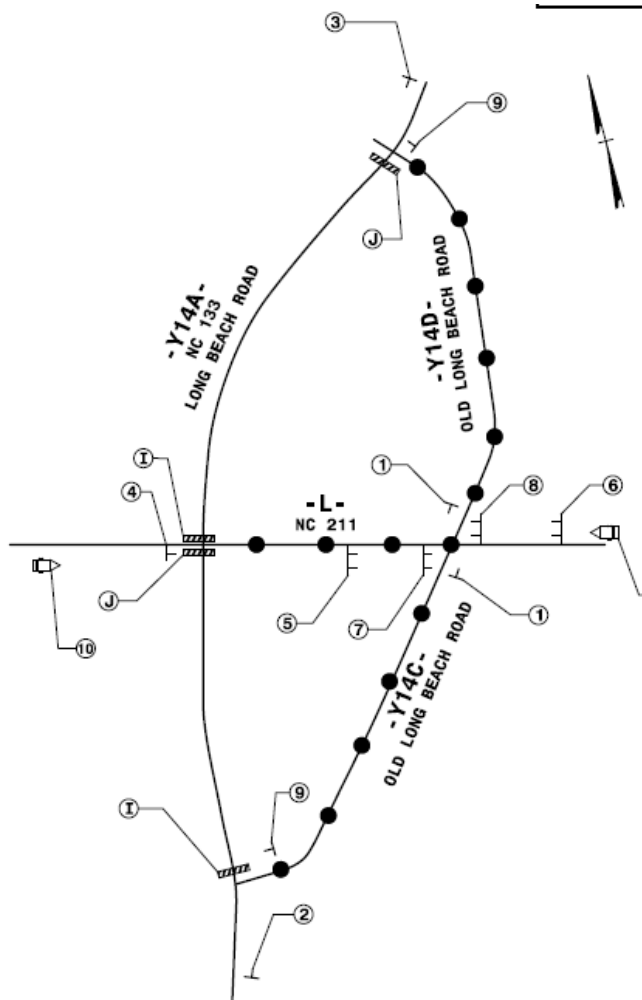

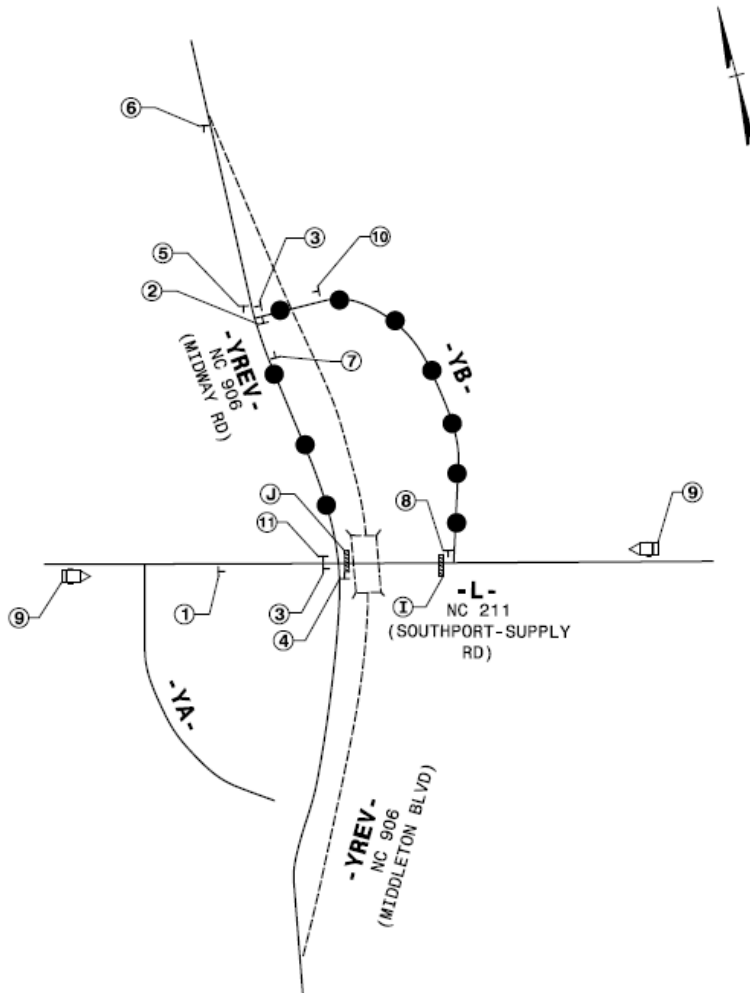

Litter Update

11 Million Pounds of Litter

NCDOT crews, contractors and volunteers have collected over 11 million pounds of roadside trash statewide since Jan. 1. This surpasses the previous record of 10.5 million pounds collected in 2019.
